Invitation for Bids for the Upgradation of Power House Access Road (CH:0+000 to 0+765)

1. The Government of Nepal (GoN), **Budhi Ganga Hydropower Project (BHP)** has allocated funds to upgrade the Access Road to the Power House Upto Chainage 0+765 of Contract Identification No. BHP-PHAR/01-071/72. Bidding is open to all eligible Nepalese Bidders.
2. **Budhi Ganga Hydropower Project (BHP)** invites sealed bids or electronic bids from eligible bidders for the **Upgradation of Power Access Road** upto Ch 0+765m under National Competitive Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.25 Million.
Minimum Work experience of similar size and nature: **two number of projects successfully completed and value of project not less than 16 Million within last 10 years.**

A complete set of Bidding Documents may be purchased from the office of **Budhi Ganga Hydropower Project, Thapagaon, Anamnagar, Kathmandu, Nepal** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, VAT registration and tax clearance certificate upon payment of a non-refundable fee of NRs.3000/- within the office hour on or before 30 days of first publication of this notice.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from BHP's Web Site ebidding.bhp.gov.np. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account no. 1201200001002524 and the scanned copy (PDF/Jpg/Jpeg format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at **Budhi Ganga Hydropower Project, Thapagaon, Anamnagar, Kathmandu, Nepal** on 13:00 hour of 21st day of first publication of this notice.
6. Sealed or electronic bids must be submitted to the office of **Budhi Ganga Hydropower Project, Thapagaon, Anamnagar, Kathmandu, Nepal** by hand/courier or through BHP website ebidding.bhp.gov.np on or before 12:00 hour on 31 days of first publication of this notice. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hour on 31 days of first publication of this notice at the office of **Budhi Ganga Hydropower Project, Thapagaon, Anamnagar, Kathmandu, Nepal**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in PDF/Jpg/Jpeg format in case of e-bid, amounting to a minimum of **NRs.500,000/-**, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to submit bid security in the form of cash, the cash should be deposited in Deposit Account Number 1201200001002524, Nepal Rastra bank, Office Code 27-308-10 and submit the receipt of the deposited amount of cash along with the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
